Our college is affiliated with Ch. Bansi Lal University, Bhiwani and established by the Government of Haryana, Higher Education Department, a co-educational running 2 years regular B.Ed. Teacher Training courses. The college has a College Council, Internal Quality Assurance Cell (IQAC) and College Development Committee. It runs as per the rules and regulations made by Government of Haryana from time to time. The college comes under "Govt-Grant" category & student's funds are collected as per the Haryana Education Code; Therefore, financial transactions are audited by auditors of Accountant general, Haryana (Govt.-Grants) as well as Local Audit Haryana (for funds collected). The college has different bodies to maintain all types of disciplines in the campus. All the Cells or Committees of the institution are under the College Principal & College Council.
